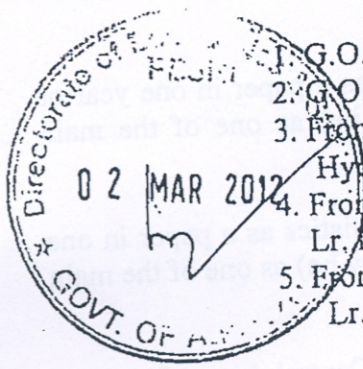

Department, dated 11.06.1991 as amended in G.O.Ms.No.165 Finance and Planning (Plg.XI) Department, dated 11.10.1999.

AMENDMENT

In the Annexure to the said Rules, in Column (3) against Category-2, Assistant Statistical Officer (formerly Statistician), for the existing entry, the

following shall be substituted with retrospective effect from 01.01.2011 namely-

**Must Possess**

- (i) Bachelor's Degree with Statistics as one of the main Subjects. or
- (ii) Bachelor's Degree with Mathematics (with Statistics as a paper in one year or two years or all the three years as the case may be) as one of the main subjects. or
- (iii) Bachelor's Degree with Economics (with Statistics as a paper in one year or two years or all the three years as the case may be) as one of the main subjects. or
- (iv) Bachelor's Degree with Commerce (with Statistics as a paper in one year or two years or all the three years as the case may be) as one of the main subjects. or
- (v) Bachelor's Degree with Computer Science (with Statistics as a paper in one year or two years or all the three years as the case may be) as one of the main subjects.

from a University established or incorporated by or under a Central Act or State Act or such institutions declared as deemed to be Universities under Section 3 of the University Grants Commissions Act, 1956 or a foreign University approved by the Central Government from time to time.




