ORDER:

The Director of Economics & Statistics in his letter read above, has stated that, the Deputy Director General, Ministry of Agriculture and Farmers Welfare, Department of Agriculture, Cooperation and Farmers Welfare, Government of India, has decided to conduct Tenth Agriculture Census with 2015-2016 (July, 2015 – June, 2016) as the reference year, which will be followed by an Input Survey with 2016-2017 as the reference year. As the Census operations are based upon the land records of the State/UTs., it is necessary that, these land records are duly updated before commencement of the actual Census operation, since it is the practice to undertake complete updating of land records by declaring the reference year for agricultural census.

2. The Director of Economics & Statistics has therefore, submitted the proposals for Constitution of Co-ordination Committees at the State and District Level to conduct and review the progress of Census work from time to time.

3. Government have examined the above proposal carefully and hereby Constitute Co-ordination Committees at the State and District Level in Telangana. The composition of the Committees shall be, as follows:-
