1. Introduction

The economic performance of a nation or state is evaluated based on its status across various economic indicators. In the context of a state, the most important used indicators are Gross State Domestic Product (GSDP) and Per Capita Income (PCI).

WHAT IS GROSS STATE DOMESTIC PRODUCT AND WHY DOES IT MATTER?

- GSDP/GDP is the value of all the final goods (e.g. cars, food, furniture) and services (e.g. services provided by barbers, taxi drivers, waiters) produced within the state's boundaries in a specific time period (usually a year).
- It is a comprehensive scorecard of a state's economic health, and can be used to estimate the size of the economy, and its growth rate.
- GSDP/GDP helps policymakers, investors, and businesses make decisions by understanding an economy's health.
- When GDP is growing, workers and businesses are generally better off than when it is not.
- When GDP is shrinking, employment often declines.
- The tax collections of a state are strongly linked with its GSDP.

There are two measures of GSDP:

- GSDP at current prices, or nominal GSDP is calculated for prices prevailing in that particular time period. Changes in nominal GSDP therefore occur on account of changes in both prices as well as quantity of final goods and services.
- GSDP at constant prices or real GSDP eliminates the contribution of inflation to the nominal GSDP growth by using prices of a selected base year for calculations. Changes in real GSDP therefore reflect changes in actual output produced, since it adjusts for the effects of inflation.



WHAT IS PER CAPITA INCOME, AND WHY IS IT RELEVANT?


- Per Capita Income (PCI) is the metric for determining a state's economic output or average income for each person residing within the state.
- It measures the amount of money that would be available per person if the total value of all goods and services produced in the economy were to be divided equally among all citizens.
- Per Capita Income is often used as a measure of the standard of living in a state.
- However, it does not account for inequalities in income distribution in the society.

SECTORS CONTRIBUTING TO GSDP


For any economy, economic activities, GSDP, and labour-force engagement can be divided into 3 major sectors, which are further divided into sub-sectors for the purpose of GSDP calculation:

- (i) Primary (Agriculture) 5 sub-sectors
- (ii) Secondary(Industry) 3 sub-sectors
- (iii) Tertiary(Services) 6 sub-sectors



WHAT IS GSVA?

- GSVA, short for Gross State Value Added, is defined as the rupee value of the goods and services produced in a state, minus the cost of all inputs and raw materials directly attributable to that production.
- It is the output of the state less the intermediate consumption, which is the difference between gross output and net output.
- GSVA is an economic productivity metric that measures the contribution of a corporate subsidiary, company, or municipality to an economy, producer, sector, or region.



HOW ARE GSVA AND GSDP LINKED?

- Gross State Value Added (GSVA) is a very important measure, which is used for calculation of the Gross State Domestic Product (GSDP).
- GSVA measures the contribution made by an individual producer, industry or sector to the GSDP, and is considered to be a better measure of the economic welfare of the population, because it includes all primary incomes.
- GSVA is related to GSDP through taxes and subsidies on products.
- It adds back subsidies that governments grant to certain sectors of the economy and subtracts taxes imposed on others, i.e.

GSVA = GSDP + Subsidies on products – Taxes on products

This publication provides figures for the GSDP of Telangana over time as per Provisional Estimates 2023-24, its sectoral breakup, and a comparison of the GSDP of Telangana with the GDP of India and with the GSDP of other states. A comparison of the state's PCI with India's PCI, Inter-state comparisons and district level data is also provided.

Such analysis assists policy makers in designing the necessary interventions for further growth.

2. Telangana Economy in 2023-24 (PE)

Gross State Domestic Product (GSDP)

At current prices, estimates of GSDP increased from Rs.13,11,823 crore in 2022-23 (FRE) to Rs. 15,01,981 crore in 2023-24 (PE). The economic growth rate, however, is estimated to decline from 16.7% to 14.5% in the aforementioned years. During the same period, the GDP of the country is expected to increase from Rs.2,69,49,646 crore to Rs.2,95,35,667 crore, with growth rate declining from 14.2% to 9.6%. Thus, the decline in growth rate at the national level is much sharper than that in Telangana. In comparison to India GDP growth rate,Telangana State growth rate is higher by 4.9 points.

At constant prices, the GSDP is estimated to increase from Rs.7,25,898 crore in 2022-23 (FRE) to Rs.7,92,941 crore in 2023-24 (PE), registering a growth of 9.2% in 2023-24 (PE) against 8.4% in the previous year. During this period, India's GDP is estimated to increase from Rs.1,60,71,429 crore in 2022-23 to Rs.1,73,81,722 crore in 2023-24, at a rate of 8.2%, in comparision with 7.0% in the previous year. Contrary to current price figures, the increase in the economic growth rate between these 2 years is estimated in Telangana by 0.9 percentage point while an increase of 1.2 percentage point in India at constant prices.

Sectoral and Sub-sectoral Performance

At current prices, the primary, secondary, and tertiary sectors are estimated to grow at 5.6%, 9.2%, and 19.4% respectively in 2023-24 (PE) in comparison to 8.8%, 10.2%, and 21.0% respectively in 2022-23 (FRE). Thus, the decline in the overall growth rate can be attributed to the lowering of growth rates in all 3 sectors.

At constant prices, the primary, secondary, and tertiary sectors are estimated to grow at 0.9%, 12.3%, and 11.3% respectively in 2023-24 (PE) in comparison to 12.5%, -1.4%, and 10.8% respectively in 2022-23 (FRE). This suggests that the decline in GSDP growth rate at constant prices is on



account of the sharp deterioration in the growth rate of the primary sector, and slight decrease in the growth rate of the tertiary sector.

Per Capita Income (PCI)

At current prices, the Per Capita Income (PCI) of the State for 2023-24 is estimated at Rs.3,56,564 as against Rs.3,12,522 in 2022-23. But the growth rate reflects a decrease from 16.2% in 2022-23 to 14.1% in 2023-24. In the same period, the national PCI is estimated to increase from Rs.1,69,496 to Rs.1,84,205 – but the growth rate reflects a sharp decline from 12.3% in 2022-23 to 8.7% in 2023-24.

At constant prices, the Per Capita Income of Telangana is estimated at Rs. 1,83,854 in 2023-24 against Rs.1,69,354 in 2022-23. This reflects an increase in growth rate of 8.6%in 2023-24 in comparison to 8.2% in 2022-23. During this period, the PCI at the all-India level is estimated to increase from Rs.99,404 to Rs.1,06,744. This reflects an increase in growth rate of 7.4%in 2023-24 in comparison to 5.7% in 2022-23.

Telangana vs. All India - GSDP /GDP at Current Prices

At current prices, the Gross State Domestic Product (GSDP) of Telangana was Rs. 15.01 lakh crores and GDP of India was Rs. 295.35 lakh crores in 2023-24 (PE). Between 2012-13 and 2023-24, the average annual GSDP growth of Telangana was 12.8% and GDP of India was 10.8%. Between 2014-15 and 2023-24, the average annual GSDP growth of Telangana was 12.9% and GDP of India was 10.3%.



- In 2014-15, Telangana's GSDP contributed approximately 4.1% to the GDP of the nation and it is increasing consistently year-on-year.
- In 2023-24, Telangana's GSDP contributed 5.1% to India's GDP, an increase of 1 percentage point since state formation.

Per Capita Income at Current Prices


The Per Capita Income of Telangana increased from Rs. 91,121 in 2011-12 to Rs. 3,56,564 in 2023-24, while that of India increased from Rs. 63,462 to Rs. 1,84,205 in this period. From 2012-13 to 2023-24, the AAGR of Per Capita Income in Telangana was 12.2%, in comparison to India's AAGR of PCI of 9.4% in the same period. From 2014-15 to 2023-24, the AAGR of PCI capita Income in Telangana was 12.4%, in comparison to India's AAGR of PCI of 9.0% in the same period.

Sectoral highlights - Current Prices

- The contribution of the primary sector to GSVA of Telangana has decreased from 19.2% in 2014-15 to 17.6% in 2023-24.
- The Gross Value Added by primary sector of Telangana grew by 168% from 2014-15 to 2023-24.
- Since state formation, the average contribution of the secondary sector to the GSVA of Telangana has been 18.1%.
- Growth rate of the secondary sector is 9.2% in 2023-24 and the Gross Value Added by the Secondary sector of Telangana grew by 140% from 2014-15 to 2023-24.
- Electricity, Gas, Water Supply and Other Utility Services registered the highest growth of 179% from 2014-15 to 2023-24 among all the sub-sectors of secondary sector.
- The tertiary sector /service sector remains the dominant sector of the state's economy accounting for 66.8% of the state GSVA in 2023-24.
- In 2023-24, the growth rate of the service sector is 19.4%, and GVA of all sub-sectors is 2 to 3 times value in 2014-15.
- Among all the sub-sectors comprising the tertiary sector, the 'Real Estate,
 Ownership of Dwelling and Professional Services sector' is the highest
 contributor accounting for 24.4% of the value added to the state GSVA.


Broad sector wise - Contribution (%)


Broad sector wise - Growth Rate (%)



Telangana vs. All-India

- Contribution of the tertiary sector to the total GSVA in Telangana in 2023-24 was 66.8%, 12.1 percentage points higher than the contribution of the tertiary sector to All India's GVA at 54.7%.
- For both Telangana and India the 'Financial, Real Estate, Ownership of Dwelling and Professional Services' sub-sector is the highest contributor to the GVA in 2023-24.



Share of Primary Sector in GSVA (%), at Current Prices





Share of Secondary Sector in GSVA (%) at Current Prices





Subsector-Wise Contribution to GSVA (%) at Current Prices





Share of Tertiary Sector in GSVA (%), at Current Prices








Tertiary Sector – Gross State Value Added (GSVA) at Current Prices










Telangana GSDP (Rs. Crores) at Constant (2011-12) Prices

Per Capita Income at Constant (2011-12) Prices








- Primary sector contribution to GSVA of Telangana is 17.1% in 2023-24.
- GVA of the primary sector grew by 80% from 2014-15 to 2023-24.
- The secondary sector is contributing around 19.8% to the GSVA of Telangana in 2023-24 and 'Manufacturing' is highest contributing sub sector in the secondary sector accounting for 12.3% of the GSVA.
- The growth rate of the secondary sector in 2023-24 is 12.3%.
- GVA of the secondary sector grew by 82% from 2014-15 to 2023-24.
- The tertiary sector is the highest contributor to the GSVA of Telangana with an average contribution of 61.8% from 2014-15 to 2023-24. This sector achieved a growth rate of 11.3% in 2023-24 and the GVA of the sector grew by 93% from 2014-15.

Broad sector wise - Contribution (%)






Broad sector wise - Growth Rate (%)



Telangana vs. All-India

- Both the secondary and tertiary sectors contribute more to the GSVA of Telangana as compared to their share in the GVA of India.
- At 17.1%, the contribution of the primary sector to the total GSVA in Telangana in 2023-24 is slightly higher than its contribution to the GVA of All India, at 16.6%.
- Contribution of the tertiary sector to the total GSVA in Telangana in 2023-24 was 63.1%, 8.5 percentage points higher than the contribution of the tertiary sector to India's GVA at 54.6%.



Share of Secondary Sector in GSVA (%), at Constant (2011-12) Prices










Tertiary Sector – Gross State Value Added (GSVA) at Constant (2011-12) Prices




